MINIMUM AMOUNT OF ORDER

PAYMENT

RETURNS

Purchaser may withdraw from contract (according to D.Lgs. 22/5/99 N°185) and return the goods within 10 days of receiving the order, informing with a recorded-delivery letter with advice of receipt to Riso Scotti spa - 27100 Pavia. The notification should indicate codes of the products you wish to return, and how you intend to be refunded (credit transfer, bank draft, etc)- hence we will need your bank details.

Purchaser will take care of sending back the products. Products must be returned to Riso Scotti in un-used condition and in their original packages - to the same address of the recorded-delivery letter. Please be sure to package well.

Upon receiving returned goods, Riso Scotti will inspect the returned purchased and refund your money as soon as possible.

Please allow us a few days for processing. If the item has signs of wear, is damaged or unsellable for any reason, the item will be sent back to you. Delivery charges will not be refunded.
